**ORDER SETTING DEADLINES FOR
INTERVENTION, DISCOVERY, AND TESTIMONY**

THIS MATTER comes before the undersigned hearing officer on the September 16, 2019 Order Scheduling Hearing to Determine New Patient Compensation Fund Surcharge Rates ("September 16 Order") and the September 30, 2019 Order Appointing Hearing Officer and Setting Initial Case Schedule ("September 30 Order") directing the hearing officer to issue a scheduling order setting deadlines for motions to intervene and discovery, as well as the filing of testimony. The September 30 Order set an October 7, 2019 deadline for PCF Staff to file written testimony, and a November 4, 2019 deadline for any party to file rebuttal testimony to the testimony presented by PCF Staff.

THEREFORE, it is hereby ordered as follows:

1. Motions to intervene as a party to this matter must be filed no later than October 17, 2019. Such motions will be ruled upon by order on or before October 21, 2019.
2. Requests for discovery must be made on or before October 22, 2019. Responses to such discovery requests must be made on or before October 29, 2019.
3. As required by the September 30 Order, rebuttal testimony to PCF Staff's testimony must be filed by November 4, 2019.
4. All motions and testimony in this docket shall be filed in the manner set forth in ¶ 6 of the September 16 Order.
