1. The amended deadline for parties to intervene is September 29, 2021.
2. The amended deadline to file exhibits, exhibit lists and witness lists is October 1, 2021. Exhibits shall be submitted in .pdf format, shall be clearly branded with the word "Exhibit" on the first page, and all pages of a multi-page exhibit shall be consecutively numbered along the bottom edge. 
