ORDER SETTING DEADLINES

THIS MATTER comes before the hearing officer after issuance of an August 24, 2021 *Order Scheduling Hearing to Determine Patient's Compensation Fund Surcharge Rates (the "Rate Order")* by the Custodian of the New Mexico Patient's Compensation Fund ("Custodian") and for scheduling purposes,

THE HEARING OFFICER HEREBY ORDERS:

1. To "file" a document in this proceeding means to send a document via electronic mail to Freya.tschantz2@state.nm.us by no later than 4:30 p.m. on the filing due date. Electronic signatures must conform to federal and state court requirements. All filed documents shall also be promptly served by the filer via email to all parties and to all persons listed on the attached Certificate of Service.
2. Pursuant to the Rate Order the deadline for parties to intervene is September 21, 2021.
3. Exhibits, exhibit lists and witness lists must be filed by September 27, 2021. Exhibits shall be submitted in .pdf format, shall be clearly branded with the word "Exhibit" on the first page, and all pages of a multi-page exhibit shall be consecutively numbered along the bottom edge. Exhibit designations shall be assigned by the hearing officer during or before the hearing.
4. To avoid confusion during the video hearing, parties are discouraged from offering any exhibit that duplicates an exhibit offered by another party.
5. Rebuttal exhibits, exhibit lists or witness lists must be filed by October 4, 2021.
6. Freya Tschantz, PCF Docketing Manager, shall compile and distribute the Exhibits to all parties, the hearing officer, the superintendent and the court reporter.

7. All other motions or pre-filed testimony shall be filed by October 4, 2021. Any testimony that is not pre-filed by October 4, 2021 must be presented live at the scheduled rate hearing.

8. This Order is effective immediately.

9. Copies of this Order shall be served via email to all persons listed on the attached Certificate of Service. OSI's Office of Legal Counsel shall also send this Order to the persons subscribed to the Patient's Compensation Fund Newsletter.


