As you may know, The Doctors Company is the largest physician malpractice insurer in the country. We insure more physicians in the state of New Mexico than any other insurance company. Given this, we and our members have a significant stake in the upcoming hearing to determine patient compensation surcharges for the coming year.

In order to be able to keep our members informed and to provide them the best possible service, we are requesting to intervene in the upcoming hearing in the docket matter referenced above. As I'm sure you are very aware, much of the information needed to evaluate the proposed surcharge has yet to be released, let alone analyzed.
