ORDER SCHEDULING HEARING TO DETERMINE PATIENT'S COMPENSATION FUND SURCHARGE RATES

The New Mexico Superintendent of Insurance, in her capacity as Custodian of the New Mexico Patient's Compensation Fund ("Custodian"), pursuant to the statutory mandates of NMSA 1978, Section 41-5-25(A), (D), and (F) (2021), and pursuant to 13.21.5 NMAC **FINDS AND CONCLUDES**:

- 1. Pursuant to NMSA 1978, Section 41-5-25(D), the Custodian is to contract for an actuarial study of the patient's compensation fund ("PCF"). Pursuant to 13.21.5.10(A) NMAC, the actuarial study is to be completed by August 1, 2023.
- 2. Pursuant to NMSA 1978, Section 41-5-25(F), surcharges shall be set by October 31 and beginning in 2021, the surcharges shall be set with the intention of bringing the fund to solvency with no projected deficit by December 31, 2026.
- 3. The Custodian believes that it is in the best interest of the PCF to adopt PCF surcharges based on evidence and comments presented at a public hearing open to all interested persons.
- 4. The Custodian has jurisdiction over the subject matter and the parties in this proceeding pursuant to NMSA 1978, Section 41-5-25.

IT IS THEREFORE ORDERED:

A. This Docket is opened for the purpose of considering PCF surcharge rates pursuant to

NMSA 1978, Section 41-5-25(D).

A public evidentiary hearing shall be held on September 21, 2023 at beginning at 9:00 В.

person interested in participating as a party must request intervenor party status pursuant to

13.21.5.10(D) NMAC no later than 5:00 p.m. on August 22, 2023.

Pursuant to 13.21.5.9 NMAC and 13.21.5.10 NMAC, the Custodian designates the PCF D.

Advisory Board as the hearing examiner to preside over the Surcharge Rate Hearing.

E. The designated hearing examiner shall have the duties and powers set forth in 13.21.5.9

NMAC.
