ORDER OF ADMISSION

COMES NOW the New Mexico Superintendent of Insurance ("Superintendent"), in her capacity as Custodian of the Patient's Compensation Fund ("PCF" or "Fund"), and, pursuant to 13.21.2.14 NMAC, HEREBY FINDS AND CONCLUDES:

- 1. The Superintendent, as Custodian of the PCF, has jurisdiction over the parties and the subject matter hereto.
- 2. Pursuant to 13.21.2.14 NMAC, upon approval for admission into the Fund, the Superintendent shall issue and deliver to the health care provider an order of admission to the Fund, which shall identify the health care provider; state that the health care provider has qualified for admission to the Fund pursuant to Section 41-5-5 NMSA 1978; specify the effective date and term of such admission; and for a hospital or outpatient health care facility for whom a base coverage or surcharge has been set, the amount of the base coverage or surcharge.
- 3. Also pursuant to 13.21.2.14 NMAC, the Superintendent shall issue an order of admission (and if applicable a subsequent order of admission renewing the admission) for every qualified health care provider first admitted to the fund since January 1, 2017.
- 4. The document attached hereto provides a record of health care providers approved by the PCF for admission into the Fund as of each provider's listed effective date. Subsequent

transactions may affect whether a health care provider remains in the Fund. It is reasonable, therefore, to direct any person seeking confirmation of the status of any

health care provider at any specific time to request such status from the PCF.

IT IS THEREFORE ORDERED:

A. Each health care provider included in the document attached hereto has qualified for admission to the Fund pursuant to Section 41-5-5 NMSA 1978 and is admitted to the

Fund as of the effective date and for the term provided therein.

B. As subsequent transactions may affect whether a health care provider remains in the

Fund, any person seeking confirmation of the status of any health care provider at any

specific time shall request such status from the PCF.

C. A copy of this order of admission shall be available for public inspection at the main

office of the Superintendent and a copy of the order shall be posted on the PCF website

as soon as practicable.

D. This docket is now closed.
